No.2/46/90-2T(2)/ 724649/1 .- In exercise of the powers conferred by clause (i) of sub-section 67 of the Motor Vehicles Act, 1988 (Central Act, No. 59 of 1988), and all other powers enabling him in this behalf and in supersession of the Government of Punjab, Department of Transport, Notification No. 2/46/90-4T(2)/598621/1 dated 30.9.2015, the Governor of Punjab hereby issues to the State Transport Authority, Punjab the following directions regarding fixation of rate of fare and freights for stage carriages in the State of Punjab, namely:-

Sr. No.	Kind of vehicle	Fare per passenger per km (in paise)	Remarks
1	Ordinary Buses	92.00	-
2	Ordinary H.V. AC Buses	110.40	20% excess of the ordinary bus fare
3	Integral Coach	165.60	80% excess of the ordinary bus fare
4	Super Integral Coach	184.00	100% excess of the ordinary bus fare

1. Provided that in case where the charging of fare involves fraction of Rs. 2.50 paise and above it may be rounded off to Rs. 5.00 and the fraction of less than 2.50 rupee may be ignored. Minimum fare shall be charged at the rate of ten rupees.
- 2 This notification will be come into force from 1<sup>st</sup> April, 2016.
