Fresh date - Opportunity for Personal hearing

This is in continuation of this office Endst. No. 11042-47 dated 28.05.2020 vide which the personal hearings in the Notices served upon operators for the cancellation/annulment of their multiple/repeated extensions of their stage carriage permits beyond the permissible limit of 24.0 Km were scheduled in the office of the undersigned as well as through Video Conference facility available in the offices of Secretary, RTA, Patiala, Bathinda, Jalandhar and Ferozepur from 8<sup>th</sup> July, 2020 onwards.

Due to conditions prevailing in the State on account of COVID-19 pandemic, some of the operators have represented that they and their advocates are reluctant to appear for personal hearing at the fixed dates and time in the month of July, 2020, therefore, personal hearing may be postponed as they will not be able to pursue their cases in a proper manner.
