- In the said orders, under the heading VLT Device registration and Activation in case of New Vehicles:-
 - (a) in Sr. no. ii, for entry " The specified public service vehicle owners will have to ensure that the VLT devices installed in their vehicles, are in working condition and regularly send required data to the corresponding Monitoring Center through cellular connectivity otherwise they will be liable for penal action as notified vide notification no. 10/166/2009-1T2/375 dated 17.05.2022."

the following entry shall be substituted, namely:-

- " The specified public service vehicle owners will have to ensure that the ATD/VLT devices installed in their vehicles, are in working condition and regularly send required data to the corresponding Monitoring Center through cellular connectivity otherwise they will be liable for penal action as notified vide notification no. 10/166/2009-1T2/827 dated 04.08.2022."
- 2. In the said orders, under the heading VLT Device registration and Activation in case of old Vehicles (retro-fitment):-
- (a) in Sr. no. i, for entry "The Public service vehicle owners will have to ensure that their vehicles are equipped with/fitted with activated vehicle location tracking device (from any of the VLTD manufacturer or its authorized dealers enlisted by Department of Transport, Government of Punjab) and one or more emergency buttons before 01.08.2022, otherwise the owner will be liable for penal action notified vide notification no. 10/166/2009-1T2/375 dated 17.05.2022, which is as under:-

within 45 days after due date (i.e. 01.08.2022)	Rs. 2,000
beyond 46 days up to 90 days after due date	Rs. 3,000
beyond 90 days after due date	Rs.500/- per day

In case of PSV registered on or after 01.01.2019:-

The Public service vehicle manufacturer or its authorized agency will ensure registration and activation of VLT device with emergency button before 01.08.2022, otherwise they will be liable for penal action notified vide notification no. 10/166/2009-1T2/375 dated 17.05.2022, which is as under:-

within 45 days after due date (i.e. 01.08.2022)	Rs. 20,000
beyond 46 days up to 90 days after due date	Rs. 30,000
beyond 90 days after due date	Rs.5000/- per day

the following entry shall be substituted, namely:-

"The Public service vehicle owners will have to ensure that their vehicles are equipped with/fitted with activated Automotive Tracking Devices and Integrated System/ vehicle location tracking device (from any of the VLTD manufacturer or its authorized dealers
