

## Office of State Transport Commissioner, Punjab, Chandigarh.

The Hon'ble High Court of Punjab and Haryana vide its order dated 11.02.2025 disposed of CWP No. 21787 of 2024 filed by M/S Orbit Aviation Pvt. Ltd. and connected cases in terms of its order dated 21.01.2025 in CWP 20651 of 2024 filed by M/S Jalal Bus Service Regd. Bathinda and connected cases vide which it has been directed that appropriate order on the show cause notice be passed by giving them personal hearing if permissible under the law.
